**REFRESHER COURSE FOR REGIONAL POPULATION EDUCATION
COORDINATORS AND PEP STAFF**

To: Bureau Director
Regional Directors

1. The Population Education program, Bureau of Secondary Education, this Department, will conduct a refresher course for the regional PopEd coordinators from DECS, CHED and TESDA on May 19-21, 1998 at the Teachers Camp, Baguio City.

2. The course serves as a retraining program with the following objectives:

- a. to update knowledge on program messages particularly reproductive health, population and development, gender and sexuality
- b. to develop program management skills in advocacy and networking
- c. to enhance capability to provide technical assistance in the use of the integration method in the teaching of population education
- d. to sustain the professional commitment to the objectives of the PopEd program in general


3. Authorized to attend are the Regional PEP Coordinators from DECS, CHED and TESDA as well as the PEP-BSE staff (see list attached).

4. Regional coordinators from CHED and TESDA shall charge their registration and transportation expenses and per diems to their respective regional funds. A registration fee of One Thousand Five Hundred (P1,500) will be charged to cover their board and lodging expenses.

Regional coordinators from DECS shall charge their transportation expenses and per diems to their regional funds. Their board and lodging however, will be charged to the PEP-BSE funds.

PEP staff shall charge their transportation and board and lodging expenses to PEP-BSE funds. All expenses shall be subject to the usual accounting and auditing rules and regulations.

5. Full cooperation of all concerned and wide dissemination of this Memorandum is desired.
