ANNUAL NATIONAL CONVENTION OF PAMBANSANG SAMAHAN PARA SA EDUKASYON SA PAGPAPAHALAGA (PSEP), INC. (Philippine Association for Values Education)

- 1. The Pambansang Samahan Para sa Edukasyon sa Pagpapahalaga (PSEP), Inc., in cooperation with the Department of Education, Culture and Sports and the Commission on Higher Education, will hold its 8th Annual National Convention on May 18 20, 1998 at the Benitez Hall, Teachers Camp, Baguio City.
- 2. The theme of the convention is "Ipagdiwang At Isulong Ang Mga Ginintuang Pagpapahalagang Pilipino". The objectives of the convention are:
