**ADDITIONAL GUIDELINES FOR THE 22nd ASEAN
SCHOOLS TRACK AND FIELD CHAMPIONSHIP**

1. **HOSTING AND PARTICIPATION**

As provided for in the DECS Memorandum No. 93, s. 1998, the Philippines through the Bureau of Physical Education and School Sports (BPESS), Department of Education, Culture and Sports shall host and participate in the 22nd ASEAN Schools Championship in Bacolod City on May 19-25, 1998.

2. **COMPOSITION OF THE PHILIPPINE TEAM**

Gold medalists and other best performers (Secondary Divisions) in the recently concluded Centennial Palaro were selected to represent the country in this Championship. The list of the Philippine delegation is in ANNEX A.

3. **TECHNICAL OFFICIALS**

The list of Technical Officials is in ANNEX B. All officials of the games shall register at Negros Occidental High School (NOHS) in the afternoon of May 18, 1998. They are requested to bring along Barong Tagalog with black pants and leather shoes.

All officials shall attend the IAAF Seminar on May 19-20, 1998.

4. **TRAINING OF THE PHILIPPINE TEAM**

The Philippine Team shall resume training in Bacolod City starting on May 14, 1998. They will be temporarily billeted at NOHS until May 18, 1998, after which they will be transferred either to Kundutel or Garden Hotel.

5. **FINANCIAL REQUIREMENT**

Expenses of the Philippine Team and the Technical Officials shall be charged to BPSS funds, subject to the usual accounting and auditing rules and regulations.


6. **CO-HOSTS**
