## 1998 REGIONAL TRAINING PROGRAM FOR SCHOOL PAPER ADVISERS

To: Regional Directors
Schools Superintendents

- 1. As a follow-through activity to the National Training Program for School Paper Advisers held at Teachers Camp, Baguio City on April 22-25, 1998, a Regional Training Program for all school paper advisers shall be held between June and July 1998.
- 2. The Regional Training Program for School Paper Advisers aims to update the participants on trends in school paper management and other relevant topics.
- 3. The participants to the regional training program shall be determined by the Regional Office in consultation with the Regional School Paper Advisers Association (RSPAA).
- 4. The school paper advisers who attended the National Training Program on April 22-24, 1998, and previous trainors of the Program shall serve as trainors during the regional training program.
- 5. The schedule of the Regional Training Program is as follows:
