

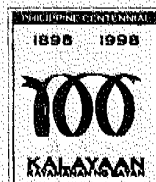

FIFTH NATIONAL YOUTH CONGRESS

To: Bureau Directors
Regional Directors
Schools Superintendents
Private and Public Secondary School Principals
Vocational High School Principals

1. The Philippine Association of Secondary School Administrators (PASSA), in coordination with the Bureau of Secondary Education, announces the holding of its Fifth National Youth Congress at Teachers Camp, Baguio City, on 7-10 September 1998. Registration is on the 7th of September. The theme of the congress is *I Am FILIPINO (I Am STRONG...I Am RESPONSIBLE)*.
2. The congress aims to help the student council leadership optimize their natural talents and their influence on the student body in ensuring the creation of a wholesome school environment for excellence in integral education. The theme shall be developed through plenary sessions and one whole day of workshop deliberations where the delegates shall be helped in formulating their personal vision and their institutional vision for the school's student council. There will be several cultural interventions, including competitions in writing and speaking, among the delegates, with special prizes at stake.
3. Participants in this congress are the student council president or senior member, and a top junior council officer, from the different PASSA member high schools nationwide. Teacher-advisers of the student councils are authorized to be with their respective student participants. In case teacher advisers cannot attend, guidance counselors may be authorized to take their places. However, their attendance in the aforementioned activity must not disrupt classes. As indicated by DECS, PASSA as the organizing entity shall provide honorarium for teachers who will substitute for those attending the Congress. This honorarium shall be given through the teacher-participants during the congress. Additional participants authorized to attend are the present members of the joint boards of directors of the three federated organization of PASSA. They will manage the congress and act as resource persons for the workshops.

4. A registration fee of three thousand four hundred pesos (P3,400.00) shall be charged each student-participant, guidance counselor, and/or teacher-adviser, member of the joint board of directors of the three federated organizations of PASSA, namely, PAPSSA, PAVEA and PRISSAP, and committee member from DECS and government schools, to cover conference materials, board and lodging, and other expenses chargeable against local school/office funds, subject to the usual accounting and auditing rules and regulations. Meals shall be served from the supper of the 7th until breakfast of the 11th of September 1998. Members of the different committees, as well as the present PASSA officials and board of directors, are authorized to travel two days before the congress

5. Participants are requested to bring a documentary report on the Student Council activities and accomplishments. These will serve as initial basis for a national student council recognition exercise that shall be initiated during the congress.

6. In view of the educational importance of this gathering to the youth participants, this Office encourages all officials to allow their respective school counselors and/or teacher-advisers of the student council to attend.

7. Immediate dissemination of this Memorandum to all concerned is desired.
