
CONSULTATIVE CONFERENCE OF REGIONAL PESS CHIEFS  
AND ASSISTANT PESS CHIEFS

To: Undersecretaries/Assistant Secretaries  
Bureau/Regional and Center Directors  
Schools Superintendents

1. The Consultative Conference of Regional PESS Chiefs and Assistant Chiefs will be held in Ma. Cristina Hotel, Iligan City on August 5-7, 1998 under the leadership and management of the Bureau of Physical Education and School Sports.
2. The conference will focus on strengthening and upgrading the implementation of the PESS program at the elementary and secondary schools in the region. Specifically, it is aimed at (1) giving an update on the progress and problems of the PESS programs implementation in the regions; (2) discussing the BPES plans and programs for SY/CY 1998-1999; and (3) realigning BPES and regional PESS programs and plans based on identified needs and thrusts and (4) organizational and technical preparations of Palara 1999 in Lanao Norte.
3. As its title suggests, the participants to this consultative conference will be composed of Regional PESS Division Chiefs and Assistant Chiefs including officials and senior staff from BPES. All Regional and Division PESS Supervisors of DECSRO-XII will have a meeting with the BPES Director on the second day of the consultative conference.

It is requested that Regional participants bring with them their regional plans and programs for SY 1998-1999 or CY 1998 and 1999, a report of program accomplishments, and identified regional problems/needs as well as the corresponding/related statistics or data.

4. Travel expenses of regional participants shall be charged to local funds while those of DECS-BPESS staff including other expenses incidental to the holding of the conference shall be charged against BPESS funds subject to the usual auditing and accounting rules and regulations. However, board and lodging of all participants shall be taken care of by BPESS.
5. The DECSRO-XII, the Schools Division of City of Iligan and the Province of Lanao Norte in coordination with BPESS shall prepare the opening and closing program as well as the arrangement for inspection of the proposed Palaro playing venues and billeting quarters.
6. Enclosed is the tentative program/schedule of conference activities.
