2ND STAFF DEVELOPMENT SEMINAR OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS NURSES' ASSOCIATION (DECSNA)

- 1. The Department of Education, Culture and Sports Nurses Association (DECSNA) in cooperation with the Health and Nutrition Center, this Department will hold its 2nd Staff Development Seminar on October 1-3, 1998 at the Romulo Hall, Teachers Camp, Baguio City. The theme of this year's seminar is "The School Nurse: Meeting the Centennial Challenges".
- 2. The objectives of the seminar are:
 - a. to update the knowledge of the school nurses on the Integrated School Health and Nutrition program;
 - b. to discuss and map out solutions to address the common issues and concerns relative to school health nursing services;
 - c. to increase the professional capabilities of school nurses in the delivery of health and nutrition services;
 - d. to strengthen interpersonal relationships and commitment among school nurses; and
 - e. to provide opportunities for the participants to share their experiences in the conduct of the different health and nutrition programs.
- 3. The seminar is in line with the provision of R.A. No. 449 re: The Continuing Professional Education required by the Professional Regulations Commission.
- 4. The participants to this seminar are the HNC nursing staff, nurses-in-charge and school nurses from public and private schools.

- 5. Transportation and other expenses of the participants incident to their attendance to the seminar, including a registration fee of two thousand five hundred pesos (P2,500.00) for board and lodging, snacks, kits, certificates and other incidental expenses shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations. Participants from private schools shall make financial arrangements with their respective schools.
- 6. Immediate dissemination of this Memorandum is desired.
