**1998 PHILIPPINE INTERNATIONAL DANCE FESTIVAL AND CONFERENCE**

To: Bureau/Service and Center Directors  
Regional Directors  
Schools Superintendents  
Private Elementary and Secondary School Principals  
Chairman, CHED

1. The Cultural Center of the Philippines (CCP) and the National Commission for Culture and the Arts (NCCA), in cooperation with the Department of Education, Culture and Sports (DECS), and Commission on Higher Education (CHED) will conduct the 1998 Philippine National Dance Festival and Conference at the Cultural Center of the Philippines, Roxas Blvd., Pasay City on August 3-9, 1998.
2. The 1998 Philippine International Dance Festival will feature nightly festival performances, lecture-demonstrations and film showings with invited international dance companies, including Singapore Dance Theater, Guangdong Modern Dance Company (China), Elisa Monte Dance Company (USA), Incepcion Dance (Spain) and Modern Dance Turkey (Turkey). The Philippines will be represented by Ballet Philippines, Philippine Ballet Theater and Ballet Manila.
3. The 1998 International Dance Conference which will be held at the Folk Arts Theater will include plenary sessions and paper presentations on the theme "Dance Revolution-Revolution in Dance".
4. A registration fee of one thousand five hundred pesos (P1,500.00) will be charged each participant which will entitle him/her to 10% discount to all festival shows.
5. Transportation and other expenses of government participants shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations. Participants from private schools shall make financial arrangements with their respective institutions.
