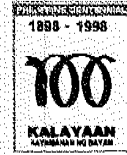


TRAINING OF TRAINORS FOR THE NATIONAL CULTURE
OF EXCELLENCE (NCE)

To: Regional Directors
Schools Superintendents
Divisional Leader Schools
Private Elementary and Secondary School Principals
Vocational High School Principals

1. The University of Asia and the Pacific (UA&P), in coordination with the Central Office of the Department of Education, Culture and Sports, announces the holding of the advanced trainors training program for the National Culture of Excellence (NCE), which was the subject of a memorandum of agreements and understanding among DECS, UA&P, Bank of Commerce (BOC), Pilipino Telephone Corporation (PILTEL), Trust International Paper Corporation (TIPCO), and the Philippine Association of Secondary School Administrators (PASSA).
2. The objective of the series is to provide the participants with the specific orientation and methodology of the NCE, including the strategies of institutionalizing it in the school set-up. The intense training of the participants will provide an efficient pool of resource persons, facilitators and lecturers to cope with training personnel requirements of the NCE program for the regions. A roster of alumni and students invited to the advanced training is attached.
3. Participants to the advanced trainors training series are graduates and students of the Master of Arts in Values Education (MAVE) of UA&P, who will be utilized to spearhead the institutionalization phase of NCE in the regions.
4. The schedule of three series is as follows:

For Visayas Trainors - 15 to 21 November 1998 at ECOTECH in Cebu City
For Mindanao Trainors - 21 to 27 February 1999 at Cagayan de Oro City
For NCR and Luzon Trainors - 18 to 24 April 1999 at Teachers Camp,
Baguio City

5. A registration fee of four thousand five hundred pesos (P4,500.00) shall be charged each participants to cover accommodations and other incidental expenses. The cost of materials, personnel resources, and training development shall be borne by the corporate sponsors. The registration fee and other incidental expenses to participation in the series shall be chargeable against local school funds, subject to the usual accounting and auditing rules and regulations.
6. Immediate dissemination of this Memorandum to all concerned is desired.

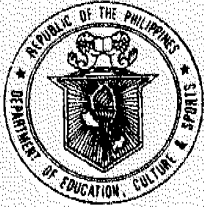

2ND KODALY INTERNATIONAL SEMINAR-WORKSHOP

1. The UST Conservatory of Music will host the 2nd Kodaly International Seminar-Workshop at the Recital Hall 2, 5th Floor, Education Building, University of Santo Tomas, España, Manila on July 24-26, 1998.
2. This seminar-workshop aims to introduce the latest music teaching methods and strategies, and to enhance competencies in music, specifically sight singing and conducting. It will offer the following courses: a) Conducting & Chorale Techniques with Prof. Angel Martin Matute (Spain); b) Solfege 1,2,3; c) Kodaly Methodology 1,2,3, and; d) Eurythmics with Prof. Gery Brondial (USA).
3. Participants to this workshop are elementary and secondary music supervisors and administrators.
