NATIONWIDE SEARCH FOR K.I.D. LISTO, ANG TIPO KONG IDOLO

To: **Bureau /Regional Directors
Schools Superintendents
Regional Science High School Principals
Divisional Leader School Principals (Secondary)
Private Secondary School Principals
Vocational High School Principals**

1. The Department of Education, Culture and Sports, and the Dangerous Drugs Board (DDB), through its Inter-Agency Committee on Drug Abuse Prevention Education, in collaboration with the Foundation for Drug Information and Communication (FDIC) announce the Second Nationwide Search for K.I.D. LISTO, ANG TIPO KONG IDOLO in all public and private secondary schools. It seeks to fulfill the following objectives:

- a. To identify and recognize youth role models who value and practice healthy, drug-free habits in their personal and school life, and
- b. To enhance the leadership qualities of the youth to enable them to take greater responsibilities in drug abuse prevention programs; and to take the lead in the formation of K.I.D. Listo Club.

2. The Search will be conducted from August to November 1998 involving Regions I - XIII (CARAGA), the National Capital Region (NCR), Cordillera Administrative Region, and Autonomous Region of Muslim Mindanao to recognize young role models who are drug-free, God-centered, responsible, trustworthy and disciplined.

3. Winners will be announced after the national screening on November 18, 1998. Cash prizes and trophies will be awarded to the K.I.D. Listo Winner, 1st runner-up and 2nd runner up during the Drug Abuse Prevention and Control Week Recognition Rites on November 19, 1998. The regional winners will further undergo leadership training on November 20-21, 1998. Travel expenses and accommodation of Regional Winners and one NDEP coordinator per region to act as the Coach/Guardian shall be provided by DDB. Financial assistance for board, lodging and transportation of contestants; and snacks/meals during the regional screening shall likewise be given by DDB.

Implementing Guidelines for the 1998 Search for "K.I.D. Listo" Ang Tipong Kong Idolo

I. Coverage

The Search is open to all first to third year high school students enrolled in public/private schools throughout the 16 regions.

II. Qualifications

1. Filipino citizen
2. Of good moral character
3. Has a high sense of responsibility in school and community activities specially in drug abuse prevention.
4. Has very satisfactory/excellent grades as a student

III. Application Requirement

1. Duly accomplished nomination form
2. Recent 2 x 2 colored photo
3. Supporting documents

IV. Mechanics

A. Nomination Procedures

1. A candidate who meets the qualifications, may be nominated by the teacher/school principal/division superintendent.
2. The following documents in triplicate shall be submitted to the Screening Committee:
 - a. accomplished nomination form duly signed by the nominating individual
 - b. 2 x 2 colored photos
 - c. certificate of good moral character signed by the barangay captain where the nominee resides.
3. Nominees shall be duly endorsed by the district supervisor for the school level, division superintendent for the division level and regional director for the regional level.

B. Selection Procedure

1. At the school level, the screening committee will be composed of the Guidance Counselor, School NDEP Coordinator and the Principal as Chairman. School level winners shall be submitted to the Division Office I on or before August 31, 1998.

2. At the division level, the screening committee will be composed of the division NDEP Coordinator, Health and Nutrition Section Head and Assistant Schools Superintendent as the Chairman. Division level winners shall be submitted to the Regional Office on or before September 30, 1998.
3. At the regional level, the screening committee will be composed of the Regional NDEP Coordinator, Chief of Secondary Education and the Assistant Regional Director as Chairman. The regional winner shall be submitted to the Project Officer DECS-DDB NDEP, Health and Nutrition Center, DECS Complex, Meralco Avenue, Pasig City, Metro Manila on or before October 31, 1998 together with supporting documents for criteria A, B, and D.
4. At the national level, the screening committee will be composed of the Representative of the IAC-DAPE, Deputy Executive Director of DDB, Chief of DDB-PETID, Director of the Bureau of Secondary Education (BSE) and the Project Officer of the National Drug Education Program (NDEP) as Chairman. They will evaluate the 16 regional winners.
5. Based on the criteria, the national screening committee will evaluate all the documents submitted by the Regional Committee and conduct personal interviews of the candidates, from which three (3) national winners will be chosen - the K.I.D. Listo, first runner-up and second runner-up. The decision of the Board of Judges is final and unappealable.
