ANNOUNCEMENT

THE 1999 ONASSIS INTERNATIONAL PRIZES

The Alexander S. Onassis Public Benefit Foundation announces that in the fall of 1999 it shall award three International Prizes as follows: D for International Understanding and/or Social Achievement, 2) for Culture and 3) for the Environment

Candidacies can be submitted to the Athens office of the Foundation at 7, Aischinou street, Plaka, Athens 105 58, attention Mrs. Barbara Haramis, the Secretary of the Prizes Committee of the Foundation, during normal office hours but not later than the 30th of December 1998.

Candidacies must be accompanied by the curriculum vitae of the candidate and any other document, books, articles or supporting material of his or her achievements.

The work of the Prize winner must be international in character. The names of the candidates shall remain confidential unless awarded the Prize.

The outstanding work of the candidates in the field of one of the three Prizes must have been performed during the last 15 years.

Candidates must not have received any international recognition for their specific worksubmitted for a prize to the Foundation.

Candidates active in the field relating to the Prize sought shall be preferred all other things being equal. This does not apply regarding the Prize for International Understanding and/or Social Achievement.

The Prize winners shall be nominated by a Committee consisting of 15 members. The nominations shall ultimately be approved by the Foundation.

The amount of each Prize is 250,000 U.S.A. Dollars.

Prizes can be awarded to persons, teams or institutions regardless of $^\prime$ nationality, origin, race or religion.

The Jury reserves the right not to award any one or more prizes.

The Jury meets in Athens and the Award Ceremony takes place in Athens.

The Prizes shall be awarded by the President of the Hellenic Republic at an official ceremony in Athens on a date which is determined by the Foundation.

It is a condition sine qua non that the Prize winner shall himself/herself be present for two full days in Athens i.e. on the eve of the date of the ceremony and on the date of the ceremony. Organisations and institutions can be represented by their highest ranking officer (President-Chairman), all others must attend personally.
