COLLOQUIUM ON TEACHER TRAINING AND DEVELOPMENT

- The School of Education of the University of Asia and the Pacific, (UA&P), in collaboration with the Goethe Institut and the Hanns Seidel Foundation, Germany, is holding a colloquium on September 14, 1998 from 1:30 to 7:00 p.m., at the Celestino Dizon Auditorium, APEC Communication Building, UA&P, Ortigas Campus, Pearl Drive, Pasig City.
- With the theme *The Teacher: The Nation's Culting Edge*, the colloquium looks at the situation of teacher training and development in the Philippines today. The activity is envisioned as a preparation for the planned Summit Conference on Teacher Education, tentatively scheduled for November 24-26, 1998 at Teachers Camp, Baguio City.
- 3. The meat of the Colloquium is a round table discussion entitled, What's Great and What's Not Quite in Our Teacher Training and Development Today. This will consist of 15 to 20-minute presentations on perspectives about the topic from field practitioners and 20-minute commentaries on perspectives regarding the topic from policy makers.
- 4. Participants in this colloquium include principals and Master Teachers of the pilot schools of Management of Culture, alumni and students of the Master of Arts in Values Education of the UA&P, Board of Directors of the Philippine Association of Secondary School Administrators and the Philippine Elementary School Principals Association, and DECS Bureau Directors, Regional Directors and Schools Division Superintendents. Substitues should be assigned to handle the classes being taught by Master Teachers.

- 5. A registration fee of five hundred pesos (P500) shall be charged each participant to cover the direct costs of the colloquium. This fee and other expenses incidental to attending the colloquium are chargeable against local funds, subject to the usual accounting and auditing rules and regulations.
- 6. Immediate dissemination of this Memorandum is requested.
