Pursuant to Presidential Proclamation No. 28 of 1986, declaring September as the National Science Club Month, the Philippine Society of Youth Science Clubs (PSYSC), in partnership with the Department of Education, Culture and Sports and the Department of Science and Technology, announces the holding of the 1998 National Science Club Month Celebration for all science clubs in all elementary and secondary
- [™] 2. This year's celebration has for its theme " Mga Science Clubbers: Bayaning Itatanghal sa Susunod na Isang Daang Taon." It aims to recognize the science clubbers as future heroes of the country by promoting public understanding of science, technology and environment at present, envisioning their applications in the future based on what has happened in the past.
 - 3. In view of this, all PSYSC Regional and Division Councils, and all local science clubs (LSC), PSYSC-affiliated or otherwise, are requested to conduct their own NSCM activities. Attached are some suggested activities to be implemented in the regional, division and school levels and the guidelines for the conduct of the same. Other activities relative to the celebration may also be conducted.
- 4. Expenses incident to the implementation of the activities at the regional, division and school levels shall be charged against local funds, subject to its availability and accounting rules and regulations, and/or science club funds.
