(An Oratorical Competition)

1. The Junior Chamber of the Philippines (JCP) or the Philippine Jaycees, Inc., in cooperation with the Department of Education, Culture and Sports (DECS) and AMA Educational System, announces the launching of its annual oratorical competition entitled "Voice of Philippine Democracy" on September 21, 1998.
2. The competition aims to: a) instill among the Filipino youth love for values inherent in a democratic society; b) develop in them the ability to reflect on the issues affecting our government and society; and c) inculcate in them the will to defend and fight to preserve our democratic ideals.
3. The regional finals will be held on October 12 to 18, 1998 and the national finals will be held in Manila on October 29, 1998.
4. The details of the competition including the rules and criteria for judging, the entry form, and the directory of regional coordinating agencies are enclosed.

"VOICE OF PHILIPPINE DEMOCRACY '98: RULES OF THE ORATORICAL COMPETITION

1. THE ORATION

- 1.1 The oratorical piece must expound on *democracy in the Philippines*.
- 1.2 All orations must be in English.
- 1.3 All orations must not exceed 1,500 words. Delivery must not exceed seven minutes. A bell will be rung once when the contestant has consumed six minutes of the allotted time. This means that he/she has one minute to finish the piece. At the end of seven minutes, the bell will be rung twice.
- 1.4 The oration shall not in whole or in part, expressly or impliedly subvert the principles of democracy nor offend any religion, sect or creed, nor violate the standards of decency nor the laws on libel and oral defamation.
- 1.5 An accomplished application form shall accompany the oratorical piece. See Inclosure No. 2.

2. PARTICIPANTS

- 2.1 Any bonafide student of any public or private high school is eligible to participate.
- 2.2 A contestant must be among the top 20 students of his/her class or section in overall scholastic standing based on previous year's performance. A certification to this effect shall be required from the Principal/school authorities.
- 2.3 First degree relatives by consanguinity or affinity of employees, directors and trustees of the JCP, AMA Education System and DECS are disqualified from the competition.

3. NATIONAL COMPETITIONS

- 3.1 Participants in the National Finals are required to submit in duplicate copies the oratorical piece they will deliver not later than October 23,

1998, direct to the National Committee – Voice of Philippine Democracy '98, Philippine Jaycees, Inc., 14 Don A. Roces Ave., Quezon City (Tel. nos. 373-7907 up to 09), along with a certification from the DECS Regional Office that they have been chosen to represent the region.

- 3.2 Likewise, two copies of the entry forms shall be enclosed with the Certification of Scholastic Record as referred to in Rule No. 2.2.
- 3.3 The national finals shall be held on October 29, 1998. Details shall be given upon submission of the entry forms.
- 3.4 JCP reserves the right to use the names and photos of the contestants and their entries for dissemination purposes using print or non-print media.

4. CONTEST GUIDELINES

- 4.1 The contest proper shall start on October 12 to 18, 1998 for the regional level. Each region shall conduct a regional contest. Each regional winner shall receive a cash prize and scholarship.
- 4.2 The winner for each region shall compete at the national level scheduled on October 29, 1998.
- 4.3 Winners shall receive the following prizes:

Grand Winner	---- P30,000 + Scholarship	Trophy + P20,000
1 st Runner-up	---- P20,000 + Scholarship	Trophy + Books
2 nd Runner-up	---- P10,000 + Scholarship	Trophy + Books

- 4.4 The transportation and overnight accommodation expenses of the finalists and their trainors shall be shouldered by the Philippine Jaycees.

5. COMPETITION MECHANICS

- 5.1 The sequence of orators' presentation shall be determined through drawing of lots.

- 5.2 Host schools that organize the regional competition will be provided with banners bearing the logos of JCP, AMA and DECS, contest theme, schedule and venue.
- 5.3 Contest mechanics and guidelines shall be written on a poster and placed on a bulletin board.

6. CRITERIA FOR JUDGING

The criteria for judging and their respective weights are as follows:

Content	-----	30%
Delivery	-----	35%
Persuasion/Audience Impact	-----	35%

CONTENT. This criterion embraces both *originality* and *timeliness* of the speech. Since the "Voice of Philippine Democracy" is the topic for all the contestants, *originality* should be taken to mean approach to and development of the topic.

Timeliness, on the other hand, should be taken to mean an awareness of the forces which constantly shape democracy here and abroad. This criterion likewise includes clarity of thought, logic of arguments, and the use of language the audience (mostly high school students) can understand.

DELIVERY. This refers to the outward manifestations of the speaker, as follows: posture, gestures, movements, eye contact, facial expression, correct pronunciation and ability to interpret emotions reflected in the oratorical piece by changing the rate, pitch and volume of his/her voice.

PERSUASION/AUDIENCE IMPACT. This takes into account the total *impact* of the entire speech as delivered by the speaker - whether it has moved the audience or not regardless of whatever reaction it may have evoked in the judges.

7. JUDGES

1. A panel of judges composed of JCP, AMA and DECS personnel will review all winning entries in the regional competition.
2. The selection of the members of the Board of Judges shall be the sole prerogative of the JCP.
