## 1998 NATIONAL CHILDREN'S SCIENCE INTERACTIVE WORKSHOP

TO

Public and Private Elementary School Principals

- As part of its annual activity, the Philippine Society of Youth Science Clubs, Inc. (PSYSC), in coordination with the Department of Education, Culture and Sports (DECS) and the Department of Science and Technology (DOST), announces the holding of the 1998 National Children's Science Interactive Workshop (CSIW) on October 23 27, 1998 at the La Vista Pansol Resort Complex, Brgy. Pansol, Calamba, Laguna.
- The Workshop is an annual event with this year's theme, "Kabataan, Pag-asa ng Kalikasan Para sa Kinabukasan ng Bayan". It aims to promote environmental consciousness among the participants and emphasize the importance of the environment and their role in preserving it. It is composed of environmental workshops, hands-on experimentation, field trip, lectures, socials, and other fun-filled interactive activities.
- 3. Each PSYSC-affiliated Science Club is allotted four (4) pupils from Grades IV VI and one (1) teacher adviser only. Those that intend to send more than five (5) delegates must notify the PSYSC as soon as possible. Participants that exceed the allotment will be wait-listed and may be accepted only in case there are still available slots. Only 350 slots are available and processing will be on a first-come-first-served basis.
- 4. The travel expenses and registration fee of Two Thousand Three Hundred Pesos (PhP 2,300.00) and other incidental expenses to this activity are chargeable against local funds, subject, however, to its availability and the usual accounting and auditing rules and regulations. As an alternative means, participants may seek the assistance of the local school board and/or various organizations to ensure maximum participation. The registration fee shall cover board and lodging, handouts, kits, field trips, and other miscellaneous expenses. Meals shall be served from dinner of October 23 up to breakfast of October 27.
  - Interested participants must submit the following on or before October 9:
    - a. Duly accomplished application form
    - b. Principal's Endorsement
    - c. Parental Consent
    - Medical Certificate

e. Non-refundable reservation deposit of Five Hundred Pesos (PhP 500.00) per participant (deductible from the registration fee) payable only to the Philippine Society of Youth Science Clubs (PSYSC) and preferably deposited at any Land Bank of the Philippines Branch with Account No. 0702-1020-65, or sent through Postal Money Order (PMO) to:

f. Copy of duly validated deposit slips.

Only after submission of all these requirements will a participant be considered reserved. The reservation fee is transferable only to participants from the same school, at which case an authorization letter must be presented by the replacement.

- 6. Each participant must bring enough clothes and pocket money for the duration of the activity, toiletries, other personal belongings and photocopy of the required documents, including a photocopy of their deposit slip for verification.
- Participation is limited to official and confirmed participants only. Confirmation slips will be mailed directly to accepted participants. If no confirmation arrives five (5) days before the activity and for more queries, participants may call the PSYSC at Tel. # (02) 433-9801 or the DECS Center for Students and Co-Curricular Affairs at Tel. # (02) 636-3603 or 631-8495.
- 8. The registration period is from 8:00 AM to 3:00 PM of October 23 only. Should confirmed participants not be able to come on time during the registration, they must inform the CSIW Committee of their delay at least three (3) days in advance.
- 9. As a co-curricular activity of the Department, all concerned are encouraged to support the Workshop. This event is part of the Department's thrust to enhance youth participation in science, technology and environment activities and education as a way to prepare them for the coming millennium.
