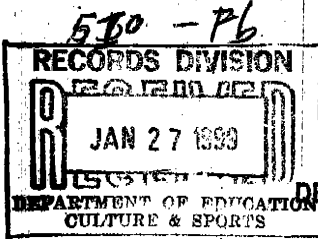
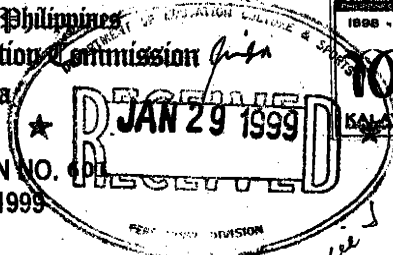

RESOLUTION NO. 601
 January 15 1999

DEFERMENT OF THE FEBRUARY 1999 EMT/SCHOOLS SUPERINTENDENTS EXAMINATION

The Commission, pursuant to Section 5 (d) of P.D. No. 223, issued Resolution No. 592 on October 26, 1998 which set the dates and determined the venues of all licensure examinations as well as the deadlines in filing applications. The resolution also fixed the EMT/Schools Superintendents Examination on February 20 and 21, 1999.

Based on the current need and pool of schools superintendent eligibles, the Department of Education, Culture and Sports thru Undersecretary Nilo Rosas in a letter dated December 23, 1998 agreed to the recommendation of the Board for Professional Teachers to put-off the superintendents examination scheduled on September 12 and 13, 1998 as well as on February 20 and 21, 1999 for the reason that there are still many superintendent eligibles who have not yet been appointed to positions requiring such eligibility.

WHEREFORE, the Commission hereby resolves to defer the EMT/Schools Superintendents Examination scheduled on February 20 and 21, 1999.

Let copies of this Resolution be furnished the Board for Professional Teachers and all officials and employees of the Central and Regional Offices of the Commission involved in the administration of licensure examinations for their information and guidance and the Department of Education, Culture and Sports for dissemination to all its Regional Offices for the information of candidates for the Superintendents Examination.
