### ADMINISTRATION OF THE 1999 LICENSURE EXAMINATION FOR TEACHERS (LET)

To: Undersecretaries
 Assistant Secretaries
 Regional Directors
 Bureau/Service/Center Directors
 Schools Superintendents
 Private Elementary and Secondary School Principals

- 1. The Professional Regulation Commission and the Board for Professional Teachers will administer the 1999 Licensure Examination for Teachers (LET), both public and private elementary and secondary levels on August 8 in fifteen (15) test centers nationwide.
- 2. Applications may be filed at the PRC Main Office, PRC regional offices for Regions I and CAR, II, IV (except Palawan), NCR, V, VI, VII, VIII, IX, X and XI from February 1 to May 31, 1999; and at the DECS regional offices for Region III, Palawan, CARAGA-Butuan City, Region XI-General Santos City, Region XII and ARMM from May 3 to May 31, 1999.
- 3. The DECS-NCR Regional Director is requested to allow the use of the premises and facilities of P. Gomez Elementary School in Sta. Cruz, Manila and Ramon Magsaysay High School in Espana, Manila as additional filing centers starting May 3, 1999.
- 4. Regional Directors concerned through the Division Superintendents in San Fernando, Pampanga; Puerto Princesa, Palawan; Butuan City; General Santos City; and Cotabato City are enjoined to provide a room or space for the PRC teams where they will temporarily hold office and receive applications, and to make available their dormitories or home economics buildings to house or accommodate the team during the application and examination periods.
- 5. All Regional Directors and Division Superintendents are also enjoined to make available selected public schoolbuildings and facilities as venues of examinations as well as the services of school teachers and other DECS personnel needed as examination supervisors and room watchers/proctors.

- 6. Inclosed are the list of regional filing/examination centers and the announcement of examination from the Professional Regulation Commission.
  - 7. Immediate and wide dissemination of this Memorandum is desired.
