SCHEDULE OF SESSIONS FOR THE THIRD NATIONAL TEACHER TRAINING CONVENTION

To: Bureau Directors
Regional Directors
Schools Superintendents

- 1. As amounced in DECS Memorandum No. 382, s. 1998, the Third National Teamer Training Convention will be held at the DECS-Ecotech Center. Luling, Cebu City from June 25 to July 7, 1999 under the sponsorship of the Books for the Barrios, Inc. (BFTB) USA in cooperation with the Books for the Barangay Foundation, Inc. (BBFT) and certain civic organizations and private corporations.
- The convention will be conducted in four separate sessions, at two days per session, for specific regions. The schedule is as follows:

- 3. A registration fee of P1,500 will be charged each participant for board and lodging at the venue, inclusive of dinner the day before the start of each session and breakfast the day after the end of the session. Expenses of participants incident to their attendance in this activity shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
- 4. It is requested that the names of participants, as specified in the aforementioned DECS Memorandum No. 382, s. 1998, be submitted to the host region preferably one month before the convention.
- 5. This Memorandum amends DECS Memorandum No. 382, s. 1998 insofar as the expenses of participants and schedule of sessions are concerned.
