**PHILIPPINE NATIONAL YOUTH GAMES**

1. The Philippine Sports Commission (PSC), the Provincial Government of Negros Occidental and the City of Bacolod will host the Philippine National Youth Games (PNYG) at the Pana-ad Sports Complex, Bacolod City, Province of Negros Occidental from April 25 to May 1, 1999.
2. The objective of this national gathering is to ensure the continuation of the sporting spirit among the students, particularly the thirteen (13) years old and below, who will compromise the regional representation to the PNYG in April 1999. It will also showcase the stakeholders' strong desire to have a sustainable program for children at an early stage, pursuing sports excellence, discipline and values inherent in the practice of sports and physical education.

## **TECHNICAL MANAGEMENT FUNCTIONS**

To ensure the smooth operation and implementation of the PNYG, the following functions shall be observed by the major stakeholders, to wit:

### **1. DECS**

- 1.1. The regional, provincial/city, district meets as well as the school intramurals shall be managed by the DECS-BPES and shall have been conducted in all regions before the end of March 31, 1999.
- 1.2. For purposes of continuity, the DECS-BPES shall take care of all eligibility and entry requirements as prescribed by existing/applicable Pajarong Pambansa guidelines on all DECS sponsored competitions. Provided, additional guidelines particularly formulated for PNYG purposes shall be observed and taken into consideration.
- 1.3. In effect, all regional delegation heads, preferably the DECS Regional Directors, shall submit to the DECS-BPES Secretariat the following:
  - 1.3.a. Form No. 137,
  - 1.3.b. Authenticated live birth certificate duly notarized by a legal counsellor,
  - 1.3.c. Medical Certificate with Accident Waiver-Release clause,
  - 1.3.d. Duly signed parental consent,
  - 1.3.e. Gallery of official names of athletes with corresponding 2 x 2 colored photograph by sport/event indicating the date of birth and name of present school,
  - 1.3.f. Computerized copy of the list of regional delegation members in diskette form, and
  - 1.3.g. Other vital documents relative to the above items.
- 1.4. The DECS-BPES shall furnish the PSC Secretariat and the NSAs of all documents relative to Item 1.3.

### **2. NATIONAL SPORTS ASSOCIATIONS**

- 2.1. The NSAs shall be responsible for the technical operation and management of their respective competitions in the PNYG including the appointment of officiating officials.
- 2.2. In so doing, the NSAs shall elect to include DECS-BPES, locally based and other qualified individuals in determining its roster of officiating officials for the PNYG.
- 2.3. For this purpose, the NSAs shall submit authenticated copies of roster of officiating officials inclusive of the following:
  - 2.3.a. Final list of officiating officials duly certified by the concerned NSA President using original NSA letterhead.
  - 2.3.b. Individually accomplished and duly signed form stating vital information of the officiating official with corresponding 2 x 2 colored photograph.
  - 2.3.c. Medical Certificate with Accident Waiver-Release Clause.
  - 2.3.d. Other vital documents relative to the above items.
- 2.4. The NSAs shall furnish the DECS-BPES and the PSC Secretariat of all documents relative to Item 2.3.

### **3. PHILIPPINE SPORTS COMMISSION**

- 3.1. The PSC shall undertake its shared responsibilities in creating support technical committees to the PNYG such as Media Affairs and Publicity, Sports Medicine Services, NSA Relations, Awards Committee, Accreditation, Sports Equipment and Supplies and other service committee deemed necessary by the PSC, provided, no duplication of committees with other stakeholders ( i.e. DECS, the LGUs of Bacolod and Negros Occidental)
- 3.2. The PSC shall spearhead the formation of an Executive Committee to oversee the smooth implementation of PNYG. The ExeCom shall decide on any issue, formulate necessary policies, guidelines and regulations, in consultation with other agencies involved in the promotion and development of sports particularly the DECS.
- 3.3. The PSC shall established the PNYG Secretariat that will serve as the nerve center and working arm of all concerned agencies.

### **4 THE PROVINCIAL AND CITY GOVERNMENTS OF NEGROS OCCIDENTAL AND BACOLOD**

- 4.1. It shall undertake its shared responsibilities in creating local organizing committee to the PNYG better known as Negros Occidental & Bacolod City Organizing Committee ( NOBOC).
- 4.2. It shall be responsible for the committees on accommodation, local transportation, security, communication, opening and closing ceremonies, program protocols, local personnel and volunteer services, medical teams, socials, competition venue upgrading and preparation, public awareness planning among others.

### **5 SPORTS INCLUDED IN THE PNYG**

There will be thirteen (13) sports in the PNYG calendar, namely: Athletics ( B/G), Badminton (B/G), Boxing (B), Chess (B/G), Football (B), Gymnastics (B/G), Little League Baseball (B), Sepak Takraw (B), Swimming (B/G), Tae-kwon-do (B/G), Table Tennis (B/G), Tennis (B/G) and Volleyball (B/G).

### **6 COMPOSITION OF A REGIONAL DELEGATION**

Each Delegate shall comprise of the following :

6.1	Head of Delegation	1
6.2	Athletic Manager	1
6.3	Physician	1
6.4	Nurse	1
6.5	Supply Officer	1
6.6	Finance Officer	1
6.7	Transportation Officer	1
6.8	Administrative Officers	5
6.9	Kitchen Assistants	10
6.10	Athletes and Coaches*	

( Note : Item 6.10 will be determined later by a technical committee)

## **7. FUNDING REQUIREMENTS**

It is suggested that a cost sharing scheme be applied in this regard ( i.e. PSC, DECS and the LGUs of Negros Occidental and Bacolod City) to effectively address funding requirements of the PNYG. It is suggested that in the funding allocation, the following examples shall be adopted.

- 7.1 Funding for BPSS operation, uniforms of BPSS personnel and members of delegation, delegation's food requirements, training gears and paraphernalia, transportation (to and from/origin and destination) allowances and honoraria among others shall be DECS funded.
- 7.2 Funding for PSC-PNYG Secretariat's operation, PSC created support committees, sports equipment and supplies ( competition proper), PSC personnel allowances, NSA competition subsidies and officiating officials' allowance among others shall be PSC funded.
- 7.3 Funding for NOBOC operation, locally organized committees, locally appointed personnel and volunteer salaries, local program operating expenses including ceremonies, socials and protocols, local transportation competition venue shall be LGU funded.

## **7. PSC INITIATED TECHNICAL WORKSHOP**

Sometime in March, 1999, the Philippine Sports Commission will initiate a tripartite technical workshop in Manila to iron-out issues and other related matters particularly in the areas of fund sharing, athletes eligibility, competition format, number of competitors per event and other related matters. All concerned individuals will be informed on the actual date and place of this exercise.

8. **PROVISIONS OF PREVIOUS DECS MEMORANDUM, ORDERS, ISSUANCES NOT RESCINDED BY THIS CIRCULAR ARE STILL IN EFFECT.**


