#### HOW

- Application forms may be obtained personally or by postal service from the Career Executive Service Board (CESB), # 3 Marcelino St., Holy Spirit Drive, Quezon City. (See location map at the back)
- 2. Applicant must file the application form directly with the CES Board accompanied by the following:
  - Copy of appointment paper and service record duly authenticated by the office personnel officer;
  - Three (3) photographs, size 2" x 2", taken not more than six (6) months before the filing of application; and
  - c) An admission fee of FOUR HUNDRED PESOS (P400.00) in cash or postal money order payable to the CAREER EXECUTIVE SERVICE BOARD. Personal checks will not be accepted.
- Only Thirty (30) applicants shall be allowed to take the examination at any given exam date. Thus, applications shall be entertained on a first-come, first-serve basis.
- 4. Deadline for filing of application is one week before the date of the examination.
