BASIC JUDO INSTRUCTOR'S COURSE - LEVEL I

1. The Philippine Amateur Judo Association (PAJA) will conduct a Basic Instructor's Course - Level I to be held on April 12 to May 29, 1999 in the Main Dojo of PAJA, Rizal Memorial Sports Complex, M. Adriatico St., Malate, City of Manila.
 2. The Bureau of Physical Education and School Sports (BPSS)-DECS is endorsing the project to all P.E teachers, coaches and technical officials. Participation approved by the Schools Superintendent shall be on official time.
 3. The course will be conducted by internationally accredited Judo referees and 4th and 7th Dan Judokas namely: Capt. Reynaldo H. Jaylo, Vice Mayor Eduardo B. Manzano, Mr. Louie B. Espiritu, Mr. Felino Ampil, Mr. Dave Carter, Mr. Luleo Panganiban and Mr. Victor B. Benedicto.
 4. The graduates of the said course will be given a Certificate of Completion, awarded an appropriate Judo rank and shall be able to:
 - 4.1 conduct the level 1 Judo beginner course;
 - 4.2 officiate (referee and judging) in their respective club level tournaments;
 - 4.3 organize and carry out regional level Judo tournaments
 5. A registration fee of One Thousand Two Hundred Fifty Pesos (P1,250.00) shall be charged to every participants that includes Certificate of Completion, Promotion Certificate, new 1999 PAJA Membership Fee, course manual, one (1) VHS tape Judo Kata, etc. Travel expenses, board and lodging, registration fee, uniform and other expenses shall be charged to the participants.
