## GUIDELINES FOR THE CY 1999 PROCUREMENT OF TEXTBOOKS THRU PUBLIC BIDDING

- 1 <u>Purpose.</u> This Memorandum is issued to apprise every official concerned with the forthcoming conduct of public bidding exercises for public school textbooks that will be funded out of the CY 1999 appropriations for textbooks and other instructional materials
- Expanded DECS-PBAC for Textbooks To ensure transparency as well as active stakeholder participation in the conduct of bidding exercises for procuring textbooks, the current DECS-PBAC is hereby expanded to include the PBAC on TEEP and the following regional and private sector representatives

- Bid Packages. The bid packages for the CY 1999 GAA FUNDED TEXTBOOK PROCUREMENT submitted by the different regions in the form of Allocation Lists

have been adjusted to conform with the Guidelines jointly prescribed by the DECS IMC and DECS PBAC.

- 6. Bidding Documents The bidding documents to be used for the CY 1999 procurement of textbooks have been patterned after the World Bank's Standard Bidding Documents Procurement of Goods These documents will govern the overall implementation of the ensuing procurement activities and it is therefore imperative for every region to closely examine their contents. Copies of the bidding documents are available at the DECS PBAC office.
