1999 REGIONAL TRAINING PROGRAM FOR SCHOOL PAPER ADVISERS


- 1 As a follow through activity to the National Training for School Paper Advisers held in Palawan for Cluster A, Cebu City for Cluster B, and Davao City for Cluster C on April 14-16 April 28-30 and May 5-7 respectively Regional Training Programs for School Paper Advisers shall be held between July and August, 1999 (See Inclosure No 1)
- 2 The Regional Training Program for School Paper Advisers aims to
 - a. upgrade the skills of school paper advisers in developing language and journalistic competence of student writers
 - b. prepare division action plans for improving the quality of school papers, and
 - c. apply the learnings gained in meaningful activities for the campus writers
- 3 The participants in the regional training shall be determined by the Regional Office (Attn: SED Chiefs) in coordination with EED Chiefs and the Regional School Paper Advisers Associations (RSPAA)
- 4 Selected school paper advisers who attended the National Training Program on April and May 1999 and the previous trainers of the program shall serve as trainers/facilitators during the regional training program
- 5 A training subsidy which shall be charged against Journalism Funds (RA 7079) in the amount of **Ten Thousand Pesos (P10,000)** per division shall be transferred by the Accounting Division this Department to the regions before the scheduled date of the training

6 A registration fee of not more than Five Hundred Pesos (P500.00) may be collected from each participant for live in designed regional programs. Travelling expenses of participants incidental to their attendance in this activity shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulation.

7 A modification of the regional training is adopted based on observations and recommendations of the participants and the monitors of the national training program conducted by clusters in April and May 1999. While it is recognized that there is a need to introduce participants to desktop publishing, this aspect of the training program on the regional level is deferred to a more opportune time to allow more extensive training on topic(s)/subject matter of urgent concern. Instead, each region is given the option to choose another topic to be included in this year's regional training. (See Inclosure No. 2)

8 A team composed of representatives of the DECS Central Office, members of the Philippine Association of Elementary School Paper Advisers (PAESPA) and the National Secondary School Paper Advisers Association (NSSPAA) shall monitor and evaluate the conduct of the regional training.

9 Immediate and widest dissemination of this Memorandum is desired.
