

## 1999 WHITE CANE SAFETY DAY

- Pursuant to Republic Act No 6759 otherwise known as An Act Declaring August 1 of Each Year as White Cane Safety Day in the Philippines and for Other Purposes , the theme for this year s celebration is 'Full Participation of Children with Visual Impairment in the Community
- The White Cane Safety Day Celebration is also the first activity of the Sight Saving Month Celebration (August) It has the following objectives
  - a to instill public awareness on the welfare of the blind,
  - b to promote recognition and acceptance of the White Cane as symbol of mobility for blind persons, and
  - c to promote and protect the physical moral and social well being of blind persons

On this day the blind persons will avail of free rides in the LRT buses and jeepney, while 50% discount fare will be given to their guides. This is made possible through the efforts of the Department of Transportation and Communication (DOTC) as cited in Memorandum Circular No. 99 869 s. 1999.

The aforementioned Activities 2.3 and 4 could also be conducted at the Regional Level under the initiative of the Regional Special Education Council Other GOs NGOs and civic organizations can be tapped for assistance

Other suggested activities for the celebration include

Information dissemination concerning the education of the visually impaired by inviting blind students or educators as resource persons and other professionals working for the blind

Holding symposia for aand/or panel discussions relevant to the prevention and rehabilitation of blindness

Conducting training on Orientation and Mobility to blind students and adults in the community and

Holding sportsfest day camps and cultural programs which will highlight the talents and skills of the visually impaired

- 4 All SPED (enters public and private schools with special education programs and regular schools are encouraged to observe this day with appropriate activities
