1999 SEMINAR WORKSHOP ON MUSIC EDUCATION

To **Regional Directors
Schools Superintendents
Private Elementary and Secondary School Principals**

1 The Philippine Society for Music Education (PSME) in cooperation with the Department of Education, Culture and Sports (DECS) and the St. Scholastica's College Music Department, will conduct the 1999 Seminar Workshop on Music Education to be held at the Little Theatre, St Scholastica s College, Leon Gunto Street, Manila on October 22-24, 1999

2 The theme of the three day Seminar Workshop is "Computer Assisted Instruction (CAI) for Music Teachers in the Elementary and Secondary Levels," which aims to assist Music teachers to

- identify curriculum materials and resources relevant to Interactive Music Learning inherent in CAI,
- gain skills in integrating CAI applications in lesson plans,
- implement CAI in the Music classroom,
- realize the importance of computers as excellent tools for enhancing the skills, performance and knowledge areas in Music education and,
- envision new applications specific to computer Music technology that will advance the goals of the Music program

3 Enjoined to participate are Physical Education and School Sports (PESS) and Physical Education, Health and Music (PEHM) regional and division supervisors, and Music, Arts and Physical Education (MAPE) and PEHM teachers from both private and public schools Participants are limited to only one hundred fifty (150) individuals

4 A registration fee of three hundred thousand five hundred pesos (P3,500 00) for each participant shall cover the cost of handouts, honoraria for lecturers and staff, technological equipment, seminar venue and other miscellaneous expenses

5 Participants from public schools may attend on official time only Participants from private institutions shall make financial arrangements with their respective schools

Likewise, teachers may be allowed to participate provided appropriate arrangements are made for make up classes
