DECS-UNICEF GREETING CARDS PROMOTION PROJECT

- The DECS-UNICEF Greeting Card Promotion Project contributed 249,910 c ards or 30% to the 1998 campaign DECS and UNICEF wish to express their appreciation for the active support and cooperation of all DECS officials, teachers and staff who contributed to the success of the 1998 campaign
- 2 Under the DECS-UNICEF 1994 Memorandum of Agreement, 25% to 30% of the net proceeds from all sales of UNICEF greeting cards in the Philippines shall be allocated specifically for education projects
- In recognition of DECS' support, education projects get the biggest share in the net proceeds from the sale of UNICFF greeting cards in the Philippines More than P4 8 million has been submitted for allocation to DECS projects from the 1998 greeting card sales net proceeds. These proceeds will again be used for projects creating child friendly learning conditions for all
- In addition to the above, handling charges equivalent to 10% of gross sales of DECS are used to finance small DECS projects like the purchase of pencils and school bags given to some first grade pupils Beginning the 1996 campaign, another 1996 is retained by sellers to reimburse them of their transportation and other relatedsales expenses
- The active participation and support of all DECS personnel concerned are again enlisted for the 1999 DECS-UNICEF Greeting Cards Promotion Project. It is hereby reiterated that the promotion and sale of UNICEF greeting cards shall be subject to the general policy that sales, particularly to pupils, students and teachers, shall strictly be voluntary and in consonance with applicable laws. Thus, it is preferred that sales promotion be directed to civic, social and business groups who are supportive of education and the welfare of children
