- 2 Recommendation/Endorsement from the School and/or Local Government Officials
- 3 Resume and other supporting documents

**D SELECTION CRITERIA**

The following criteria shall be considered in the selection of GAWAD KKK awardees

*Degree/Extent of Involvement* 40%

This refers to the nominee's actual participation and performance and the extent to which his/her participation/performance has actually contributed in attaining excellence in their respective fields despite the difficulties encountered. As such, particular and peculiar circumstances or difficulties must be presented.

*Awards and Achievements Received* 30%

This refers to the awards and achievements previously attained by the nominee. Said awards and achievements must have direct relation to the category being sought.

*Character* 30%

This refers to the basic character and spiritual bearing of the nominee. A written testimony detailing facts or events evidencing the basic character and spiritual bearing of the nominee by at least two persons with known integrity must be submitted together with the other supporting documents.

**F MECHANICS**

1. The Search is set in motion by direct nomination only either by the individual nominating himself/herself or by another person or organization nominating another individual.
2. Upon submission of the accomplished nomination forms, resume and other supporting documents on or before January 15, 2000, the Board of Judges shall rate the nominees based on the selection criteria, the result of which shall be deliberated upon by the members thereof.
3. Winners of the Search shall be notified by the GAWAD KKK Secretariat. Transportation, food and accommodation expenses of the awardees shall be shouldered by the organizers.
4. Awarding shall be on February 4, 2000 at exactly 8:00 PM at the Riverbend Hotel, Bonifacio Avenue, Barangka, Marikina City.
