THIRD NATIONAL CONFERENCE ON PRIVATE PRESCHOOL EDUCATION

To Regional Directors  
Schools Division/City Superintendents  
Private Elementary and Secondary School Principals

1 The Coordinating Council for Early Childhood Education in the Philippines Inc (CONCEP), a NGO composed of preschool educators, administrators and teachers, has been recognized as the coordinating body of the Department of Education, Culture and Sports (DECS) in preschool education since 1987

2 Corollary to this, CONCEP will hold its Third National Conference on February 24-25, 2000 at the Holiday Inn United Nations Avenue Ermita Manila with the theme "CONCEP's Quest A Sustainable Development of Quality Preschool Education

3 The conference aims to a) upgrade the quality and delivery of preschool education in the private schools, b) acquaint private preschool teachers and administrators with the policies on preschool education and c) discuss issues and concerns on preschool education

4 The organizers have made arrangements so that attendance in the conference will be given credits in the graduate level by Miriam College Graduate School or in the Continuing Professional Education (CPE) of the Professional Regulation Commission (PRC)
