2 The theme of the convention is "Benchmarking for Excellence" It also aims to offer an opportunity for the Centers of Excellence/Centers of Development (CoeS/CODs) to exchange experiences share best practices and obtain feedback on their performances in carrying out their mandated functions in accordance with the provisions of Republic Act 7784

3 Participants to the convention are the Presidents, Deans and Program Coordinators of the College of Education of the Centers of Excellence and Centers of Development (COEs/CODs) for Teacher Education CHED Regional Directors, Teacher Education Council (TEC) members from the Commission on Higher Education (CHED) National Commission for Culture and the Arts (NCCA) and the Professional Regulation Commission (PRC) zonal representatives from Luzon, Visayas and Mindanao and teacher representatives for Language Mathematics, Social Studies and Science and Technology

4 Food and accommodation for the official participants will be shouldered by the Teacher Education Council Transportation and other allowable expenses of participants from government institutions shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations Those coming from private institutions shall make financial arrangements with their respective schools/offices
