PRINCIPAL EMPOWERMENT PILOT PROJECT REVIEW

1 In pursuance to DECS Order No 2 s 1997 entitled 'Adopting a Policy of Empowering School Principals and DECS Memorandum No 107 s 1997 on the National Planning Workshops on the Implementation of the Principal Empowerment Pilot Project the Department of Education, Culture and Sports in cooperation with the ADB Technical Assistance on Decentralization of Basic Education Management will conduct the Principal Empowerment Pilot Project Review on March 9 11 2000 at the Applied Nutrition Center, Banilad Cebu City

2 The three-day review conference aims to

- a determine the extent of the implementation of the pilot project,
- b re-examine the implementing guidelines and specify key areas and components where favorable/non-favorable results and outcomes are obtainable
- c identify factors that enabled/hindered the efficiency and effectiveness of the project and its implementation, and
- d formulate recommendations for actions that can help in directing and/or redirecting the decentralization efforts of the department

3 Participants to this workshop are the selected elementary and secondary school administrators who participated in the pilot project listed in the enclosure They are expected to arrive in the venue in the morning of March 9, 2000 for the registration and opening activities The workshop-conference will officially start at 1 30 p m on the same day and will end 12 00 noon of March 11 2000

4 The participants are requested to prepare a brief project implementation report highlighting a) what went well, b) what did not go well, and c) recommendations. Additionally they are also requested to bring copies of the following documents which were the outputs of their training conducted in Baguio City last April 21-25, 1997: School Educational Development Plan, Project Proposal and Performance Contract.

5 Schools division/city superintendents are requested to allow the participation of the participants on official time.

6 The costs for board and lodging and travel of participants shall be funded by the ADB TA. The travel expenses shall be reimbursed during the workshop upon presentation of the required documents. Other expenses related to this activity shall be charged against the HRDS Training and Development Funds subject to the usual accounting and auditing rules and regulations.
