**SECOND ANNUAL CONVENTION OF THE NATIONAL ORGANIZATION  
OF PROFESSIONAL TEACHERS**

To Regional Directors

1 The National Organization of Professional Teachers, Inc. (NOPTI) duly recognized by the Board for Professional Teachers and Professional Regulation Commission, is "the one and only integrated and accredited association of professional teachers," as provided in Sec 22 R A No 7836 The organization works in coordination with this Department in the continuing professionalization of all public and private school teachers in the elementary and secondary levels

2 Pursuant to this mandate NOPTI in coordination with DECS will be holding its Second Annual Convention at the Development Academy of the Philippines Tagaytay City on May 5-6 2000 The theme of the convention is "Teachers Response to the Challenges of the New Millennium"

3 The convention seeks to pursue the following objectives

- a Update teachers on the latest educational laws and school legislations enacted by Congress
- b Set the direction for NOPTI activities in the new millennium and
- c Promote awareness of the role of NOPTI in the professionalization of teachers and other related services.

4 Participants to this convention are officers of NOPTI in the district, division and regional levels Those from public schools are allowed to attend on official time only

5 A registration fee of One Thousand Eight Hundred Pesos (P1 800 00) will be charged each participant to cover cost of snacks lunch materials accommodation and rental of function rooms

6 Transportation registration and all other expenses incidental to participation in the convention of those from public schools will be sourced through private funds, not DECS funds Participants from the private sector shall make arrangements with their respective schools

7 Pre-registration with payment by district division, and region is requested Such payment should be remitted to Mrs Erlinda S Dayos Chairman Committee on Finance Confirmed list of participants should likewise be submitted on or before April 28 2000

8 Check in is morning of Friday May 5 lunch included and check out is Saturday at 5 00 p m Opening ceremonies is Friday at 1 00 p m closing ceremonies is Saturday at 4 30 p m
