### GUIDELINES ON THE USE OF PUBLIC SCHOOL FACILITIES AND SUPPORT PERSONNEL FOR PRC LICENSURE EXAMINATIONS

## **MEMORANDUM OF AGREEMENT**

#### KNOW ALL MEN BY THESE PRESENTS

This Memorandum of Agreement is made and entered into by and between

DEPARTMENT OF EDUCATION, CULTURE AND SPORTS, a government institution with office address at ULTRA Complex Pasig City represented herein by its Secretary, Hon ANDREW B GONZALEZ FSC hereinafter referred to as DECS

and

PROFESSIONAL REGULATION COMMISSION, a government institution with office address at P Paredes St. Sampaloc Manila represented herein by its Chairman Dr HERMOGENES P POBRE, hereinafter referred to as PRC.

### WITNESSETH

WHEREAS, DECS has general supervision over public elementary and high school buildings all over the country which can be utilized by the PRC during licensure examinations

WHEREAS, for licensure examinations in the National Capital Region the PRC has signified its intention to use the buildings of the following public elementary and high schools in the Division of City Schools in Manila

WHEREAS, for licensure examinations in the other regions the PRC has also expressed its intention to use public elementary and high school buildings for licensure examinations and shall submit to the DECS such list of schools from time to time after due consultation with its regional offices

NOW, THEREFORE for and in consideration of the foregoing premises and of the terms and conditions hereinafter set forth the parties hereto have mutually agreed as follows

- (1) This agreement has a duration of one (1) year effective upon its signing unless earlier terminated by either of the parties with a written notice at least ten (10) days prior to termination. It may be renewed for another similar period subject to the mutual consent of the parties.
- (2) The PRC will give the DECS through the Principal/s of the public elementary and high school/s intended to be used sufficient notice which is at least one (1) month before the date of the examination by forwarding a letter request to use said school/s in order to give the said school/s enough time to prepare the classrooms
- (3) The DECS not charge the PRC rental fees and utility charges for the use of the said public elementary and high school/s
- (A) The PRC shall provide honoraria to school officials and personnel who will render services directly related to the conduct of examinations such as coordination arrangement of chairs and tables maintenance of cleanliness security of tests materials and the examination site and provision of electricity and water supply as follows

(5) The rate of honoraria shall be as follows

- (6) School Janitors shall be paid in addition to the daily allowance for actual service on the day/s of the examination a daily allowance one day before the examination for arranging the seats in accordance with the seating plan hauling of seats in case of need and after the examination for cleaning the rooms used in the examination and for returning seats where they were taken
- (7) The DECS Principals or School Coordinators concerned shall furnish the PRC with a certified list of personnel to be assigned before during and after the examinations who shall all sign on the PRC Daily Attendance Sheets

- (8) The PRC Examination Disbursing Officer shall pay the school officials and other personnel for services rendered on the last day of examination
- DECS shall issue a memorandum to the Division Superintendent/Supervisor and principals concerned to make the facilities of their respective schools available to PRC for examination purposes when requested
