SUBJECT: **NATIONAL JUNIOR LEADERS' ENCAMPMENT 2000**

- 1 We are pleased to announce the holding of the National Junior Leaders Encampment 2000 at Casiguran Sorsogon with Bicol Region as the host region.
- 2 The encampment objectives:
 - a to provide Scouts with opportunities to meet and exchange ideas, skills and experience in leadership of boys
 - b introduce new activity and experience areas that may be adopted in the program and of interest to Scouting
 - c reinforce traditional Scouting values and skills.
- 3 Particulars are as follows:
 - a Date 01-05 August 2000
 - b Venue Casiguran Sorsogon
 - c Qualification for participation:
 - 1 Scouts must:
 - a be currently registered Boy/Senior Scouts
 - b be 12 years old but not over 17 ½ years of age
 - c be holder of First Class or Pathfinder Rank
 - d have good traits of leadership
 - e be physically fit as certified by a physician
 - f have sufficient camping experience
 - g have parent's / guardian's permit
 - h be equipped with camping gears

2 Scouters

- a must be currently registered
 - b must be currently trained and have served as UL or AUL for at least two (2) years
 - c must be of good moral character
 - d must be physically fit as certified by a physician
 - e must be equipped with camping gears
- d Participation Ratio One (1) Adult Leader for every eight (8) Scouts
- e Registration A registration fee of FIVE HUNDRED PESOS (Php 500.00) to defray program materials, souvenir items and other operational budgetary needs shall be charged each participant
- f Food Provision Troops/Units of the contingent will bring their own provision and manage their own mess. A Jamboree Market will be set up to make available food supplies
- g Transportation and Equipment Contingents will arrange and handle their own transportation to the camp site and return. Like in any other camping, Scouts are encouraged to pitch their own tents
- 4 The targeted participation of the Local Councils/Region shall be
