- 1 The Bureau of Secondary Education (BSE) this Department will conduct a Consultative Conference on the Use of the High School Occupational Interest Inventory (HSOII) on June 28-30 2000 at the Villa Cristina Resort and Hotel Taktak Road, Antipolo City
- 2 The consultative conference aims to
 - ◆ gather feedback on the pilot implementation of the use of the HSOII and
 - ◆ draw recommendations for the institutionalization of the use of the HSOII
