- 3 Participants shall be sent individual letters indicating the specific schedule and venue of the workshop he or she must attend and contacted directly by staff from the DECS-IMCS or through the Regional Textbook Evaluation Coordinators (TECs) re final preparations and arrangements for the workshop
- Expenses for the transportation of participants for this workshop shall be charged against local funds. All other expenses for the conduct of this workshop such as for communications, supplies, board and lodging of all participants travel expenses and honoraria for resource persons/facilitators and other necessary expenses shall be chargeable against the trust fund for textbook evaluation.
- 5 Regional directors schools division/city superintendents, and school heads are enjoined to facilitate the participation of pre-selected potential evaluators to the training workshop
