# REGIONAL TRAINING PROGRAM FOR SCHOOL PAPER ADVISERS SY 2000-2001

- To Regional Directors
  Schools Division/City Superintendents
- In order to enhance the skills gained by the school paper advisers during the National Training Program for School Paper Advisers held at the Teachers Camp Baguio City on April 26-28, 2000 a Regional Training Program for all school paper advisers shall be held between July and August 2000
- 2 The regional training program aims to
  - a further upgrade the teaching competencies and journalistic skills of elementary school paper advisers on photojournalism as well as in layouting feature writing editorial writing and sports newswriting
  - b equip the secondary school paper advisers with the necessary skills on Desktop Publishing using the Pagemaker Program and
  - c discuss with/orient the participants on the new scheme to be used in judging the group contests for the National Schools Press Conference SY 2000-2001
- The participants to the regional training program shall be determined by the Regional Office (Attn SED Chief) in consultation with the EED Chief and the Regional School Paper Advisers Association (RSPAA)
- The school paper advisers who attended the national training program shall serve as trainors/facilitators during the regional training program
- 5 Elementary level participants are requested to bring the following for the photojournalism activities
  - Camera
  - 1 roll (12-shots) film
  - ♦ 1/2 size cartolina

Film developing shall be charged against local funds

A training subsidy which shall be charged against Journalism Funds (R.A. 7079) in the amount of Ten Thousand Pesos (P10 000 00) per division shall be transferred by the Accounting Division, this Department, to the regions after the training design is submitted to and subsequently approved by the Bureau of Secondary Education. The deadline for submission of the Training Design is on June 16, 2000. For a more effective and efficient result, regional training by division is discouraged.

- 7 A registration fee of not more than Five Hundred Pesos (P500 00) may be collected from each participant for live-in designed regional programs. Travelling expenses of participants incidental to their attendance in this activity shall be charged against local funds subject to its availability and the usual accounting and auditing rulls and regulations.
- 8 The schedule of the regional training programs are as follows

- 9 The organizers of the different regional training programs are enjoined to strictly implement their training programs according to the aforementioned schedules in order to effect a smooth flow of monitoring activities. Any deviation from the set schedules shall not be allowed Further this may be a ground for the delay in the remittance of the subsidy to the Regional Office from the DECS Central Office.
- A team of monitors from the DECS Central Office officers/members of the Philippine Association of Elementary School Paper Advisers (PAESPA) and the National Secondary School Paper Advisers Association (NSSPAA) shall be in the regions to serve as resource persons and/or to gather information about the conduct of the regional training. The list of monitors for the regional training program is enclosed.
- 11 Immediate and widest dissemination of this Memorandum to all concerned is expected
