## AECE 18TH ANNUAL CONFERENCE

- 1. The Association of Early Childhood Educators (AECE), will hold its annual conference with the theme, "Investing in the Future: Our Children," on October 19-21, 2000 at the Quezon City Sports Center, E. Rodriguez Sr. Blvd. (fixmerly España Extension) Quezon, City.
- 2. The conference aims to bring to the fore its concerns in educating young children, aged 0-8 years. It has three strands namely: 1) School Management (Surviving the Competition), for school owners, managers, administrators and leaders; 2) Teaching Learning (Diverse Programs for Diverse Needs), for teacher-educators, trainers, teachers, academic coordinators, caregivers; and 3) Parenting and Advocating for Children (Cost, Quality and Outcomes), for parents, guardians and advocates of early children delivery.
- 3. Participants to this conference are education officials, specialists, supervisors, administrators, managers, teacher-trainers, teachers, researchers, and other stakeholders in early childhood education in both public and private educational institutions. Participants coming from public schools are allowed to attend on official time only. Those coming from private institutions may make financial arrangements with their administrators.
- 4. Participants may avail of the following fee schedule: a) Early bird registration (before August 18, 2000), Three Thousand Pesos (P3,000.00); b) AE(3E members and affiliates, Three Thousand Two Hundred Pesos (P3,200.00); and c) Non-AECE members, Three Thousand Five Hundred Pesos (P3,500.00) only. The registration fee entitles the participant to active participation in the sessions, conference kit, 3 lunches, 6 snacks and a chance to build a network of friends nationwide.
