2000 PHILIPPINE NATIONAL YOUTH GAMES-BATANG PINOY PROGRAM

- 1. The Philippine Sports Commission (PSC) and the Provincial Government of Laguna will host the 2000 Philippine National Youth Games-Batang Pinoy National Championships at the New San Luis Recreational, Educational, Cultural and Sports (RECS) Complex in Sta. Cruz, Laguna on October 22-28, 2000.
- 2. As envisioned in Executive Order No. 44, the objective of this national sports gathering is to ensure the continuation of the sporting spirit among the in-school and out-of-school children-athletes, particularly the twelve (12) years old and below, who will comprise the provincial representation to the PNYG-BP National Championships this October 2000. It will also showcase the stakeholders' strong desire to have a sustainable grassroots development program for children at an early stage, pursuing sports excellence, discipline and values inherent in the practice of sports, play and physical education.
- To ensure effective and efficient implementation of the PNYG-BP 2000 Program as well as its National Championships, the fellowing activities shall be conducted jointly by the DECS, DILG-LGU, PSC and the concerned National Sports Associations for the months of August and September 2000.

- 4. The purposes of the abovementioned activities are as follows:
 - 4.1 To adequately enhance the officiating and coaching capabilities of locally-based coaches and officials with latest technical information as prescribed by the concerned NSAs being the technical authorities in the country of their respective International Federations;
 - 4.2 Finalization on format of competition by sports and events as well as technical games rules and regulations;
 - 4.3 Inspection and finalization of competition venues and billeting facilities;
 - 4.4 Athlete's Eligibility Requirements;
 - 4.5 Schedule of competitions and official number of athletes and delegation officials;
 - 4.6 Accreditation and designation of Officiating Officials;
 - 4.7 Formation and creation of various working committees;
 - 4.8 Budget and financial requirements;
 - 4.9 Delineation of functions and responsibilities among cooperating agencies; and
 - 4.10 Other related matters.
- 5. Transportation expenses of all authorized DECS participants shall be charged against their respective local funds and shall be subject to existing accounting and auditing rules and regulations.
- 6. The PSC shall take care of the board and lodging of all participants in the above mentioned activities and programs. Likewise, administrative preparations shall be the responsibility of the PSC.
- 7. Invitations shall be sent by the PSC to all regional offices for proper dissemination to all concerned local offices, divisions, bureaus and units.
