**ADDENDUM TO DECS MEMORANDUM NO. 279, S. 2000  
(DECS Supports "Saludo Para Sa Kawayan Pilipino" Project)**

1. Paragraphs 2 and 3 of the aforesaid DECS Memorandum is hereby corrected to read:

"2. This project will benefit the brave soldiers who died in the battle, those who will be unable to work permanently due to the injuries they suffered in line of duty against the Muslim extremists and the teachers and students who were victims and who became hostages of the said Muslim rebel groups".

"3. In support of this noble undertaking, DECS encourages all regional directors, schools superintendents and other school officials to allow the Anak ng Masa Foundation to pass coin banks (takansya) in every classroom for the "Piso Para sa Sundalo at sa Guro Program". The proceeds will go to the "Saludo Para sa Kawayan Pilipino Project" to provide for their children's education and livelihood as well as for teachers and pupils/students who were hostage victims. Contributions are voluntary.

Further, the Anak ng Masa Foundation with the DECS-Special Events Unit would like also to ask your help by sharing your old clothes, blankets, and goods to the other victims of calamity like the teachers and other civilians especially in Region XII (Central Mindanao), Region III (Bulacan, Pampanga) and some parts of Metro Manila (NCR).
