3RD STAFF DEVELOPMENT SEMINAR OF THE DEPARTMENT OF EDUCATION, CULTURE AND SPORTS NURSES' ASSOCIATION (DECSNA)

- 1. The Department of Education, Culture and Sports Nurses' Association (DECSNA) in cooperation with the Health and Nutrition Center, this Department, will hold its 3rd Staff Development Seminar on October 6-7, 2000 at Benitez Hall, Teachers Camp, Baguio City with the theme "Health and Nutrition Millennium Challenges: School Nurses' Concern".
- 2. The objectives of the seminar are to:
 - update the knowledge of the school nurses on the thrusts of the Integrated School Health and Nutrition Program;
 - discuss and map out solutions to address the common issues and concerns relative to school health nursing services;
 - increase the professional capabilities of school nurses on health care delivery;
 - d. provide opportunities for the sharing of experiences on effective health and nutrition program implementation; and
 - e. strengthen interpersonal relationships and commitment among school nurses.
- 3. In view of the benefits that will be derived from the paper presentation and interactive sessions, all HNC nursing staff, nurses-in-charge and school nurses of public and private schools at all levels are enjoined to attend on official time.

- 4. A registration fee of One Thousand Seven Hundred Fifty Pesos (P1,750.00) shall be charged each participant to include board and lodging, snacks, kits, certificates of participation and attendance; and other incidental expenses. Expenses incurred relative to their attendance to this activity are charged against personal/private funds. Participants from private schools can make financial arrangements with their respective administrators for their travel expenses.
