**2<sup>ND</sup> ANNUAL CONFERENCE OF SCHOOL LIBRARIANS AND MEDIA SPECIALISTS**

To: Regional Directors  
Schools Division/City Superintendents  
District Supervisors/Principals  
School Librarians/Media Specialists

1. The Department of Education, Culture and Sports (DECS), announces the holding of a 2<sup>nd</sup> Annual Conference of School Librarians and Media Specialists at the Butwagan ng Karunungan, DECS Central Office, Meralco Avenue, Pasig City on November 21-23, 2000. The DECS Library and Information Center Staff shall be the lead agency in this activity.

2. The theme of the Conference is "School Library Media Center: Purveyor of Knowledge, Technology and Diversity". It aims to:

- a. plan and design a school multimedia library program which ensures access and utilization of resources and services;
- b. provide training in the organization, management and maintenance of an effective learning center; and
- c. provide hands-on training on techniques and application of information technology in school library media centers in support of classroom curricular activities.

3. Authorized to attend are one (1) school librarian/media specialist and/or one (1) superintendent or district supervisor per district. Only one hundred twenty (120) participants will be accommodated on a first come-first served basis.

4. The conference fee of One Thousand Five Hundred Pesos (P1,500:00) plus expenses for travel and board and lodging of participants shall be charged to school local funds, subject to its availability and the usual accounting and auditing rules and regulations.
