The following shall form part of DECS Memorandum No. 493, s. 1998 on orth National School Enrolment Day issued on December 11, 1998.

The child's birth certificate is needed to enrol the child as stipulated in 3 of Presidential Decree No. 651. If the birth certificate is not available the following documents may be accepted: baptismal certificate; affidavit by parent or guardian; or sworn statement of the parent attested to by rangey captain certifying the date of birth of the child. However, before start in June, the birth certificate has to be presented.
