COMMITTEE FOR THE "PISO PARA SA SUNDALO AT GURO PROGRAM"

1. Pursuant to DECS Memoranda Nos. 279 and 330, s. 2000, DECS supports "Saludo Para Sa Kawal Pilipino" project, a joint undertaking of the Anak ng Masa Foundation (AMF) and DECS-Special Events Units (DECS-SEU).
