**NATIONAL WORK-CONFERENCE OF CHIEFS AND ASSISTANT CHIEFS  
OF ELEMENTARY EDUCATION ON ACCREDITATION PROGRAM**

To: Bureau Directors  
Regional Directors

1. The National Work-Conference of chiefs and assistant chiefs of elementary education on accreditation program for public elementary schools will be held at Island Cove Resort and Leisure Park, Binakayan, Kawit, Cavite on October 9-13, 2000.
2. The theme of the conference is "Quality Education Thru Accreditation". At the end of the workshop, the participants are expected to:
  - a. demonstrate knowledge and appreciation of accreditation program as a means of improving school performance;
  - b. demonstrate skills as accreditors;
  - c. formulate regional initiatives in preparation for regional participation in the accreditation program; and
  - d. update knowledge on current trends and innovations in elementary education.
3. Participants to this work-conference are the chiefs and assistant chiefs of the Elementary Education Division (EED) of the sixteen (16) regions, and the director, assistant director, division chiefs and assistant chiefs of the Bureau of Elementary Education (BEE).
4. Transportation will be provided to ferry participants from DECS-CO to the conference venue. Assembly place will be in front of the DECS Canteen on Monday, October 9 at 8:00 a.m. Official accommodation will start with morning snacks on October 9 and will end at breakfast on Friday, October 13. However, the session from October 12 (morning snacks) to October 13 (breakfast) will be funded by TEEP including board and lodging of participants.
5. Travel expenses and a registration fee of Six Thousand Pesos (P6,000.00) per participant to cover board and lodging and other related expenses shall be charged against local funds subject to the usual accounting and auditing rules and regulations.
6. Enclosed are the Program of Activities and the List of Participants.
7. Immediate dissemination of this Memorandum is desired.
