1 Enclosed is a copy of Presidential Proclamation No 355 dated August 14 2000 entitled "Authorizing the United Way Philippines Inc to Conduct a National Fund Campaign for a Period of One (1) Year" The campaign shall start from August 2000 until July 2001

3 In view thereof school administrators from both public and private schools are encouraged to extend support to UWPI All contributions however should be strictly on a voluntary basis Teachers and pupils/students should not be required to contribute to fund campaign considering its being voluntary in nature


