**NATIONAL REFRESHER COURSE FOR DECS, PFF FOOTBALL
INSTRUCTORS AND TRAINORS**

1. The Philippine Football Federation (PFF) is a recipient of a grant from the Federation of International Football Association (FIFA) for the development of the sport in the Philippines.
2. The Department of Education, Culture and Sports (DECS) in partnership with the Philippine Football Federation (PFF) has been implementing an extensive football training for elementary school teachers throughout the country since May 1999 covering 5,373 elementary schools, public and private, involving 12,360 Grades I-IV teachers.
3. The National Refresher Course is a training workshop to upgrade the skills and competencies of trainers/instructors in conducting seminar for the Grades V-VI teachers/coaches starting year 2001. The training-workshop shall be held on January 6-13, 2001 at Dorm A, Philippine Sports Complex, Meralco Avenue, Pasig City.
4. The participants to the training-workshop are those trainers who already conducted the teachers training seminar-workshop in their school district and division from June 1999 to December 2000.
5. The PFF shall provide free technical assistance and other instructional materials to selected and additional instructors. Likewise, board and lodging of participants including transportation expenses of lecturers, management and support staff as well as other expenses incidental to this activity shall be borne by the PFF.
6. The regional directors, schools superintendents, schools principals and heads of schools shall arrange the official participation of the selected and additional participants provided for in the enclosed list.
