7TH NATIONAL DAMATH COMPETITION AND LAUNCHING OF COMPUTER-BASED e-DaMath

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents
Private Elementary and Secondary Schools Principals

- 1. The Department of Education, Culture and Sports (DECS) through the e-DaMath project of the Curriculum Development Division, Bureau of Secondary Education, in partnership with the Department of Science and Technology and the Belgosa Media Systems, Inc. through Bato Balani Foundation, Inc. and in cooperation with the host DECS Region VII, will conduct the 7th National DaMath Competition and launch the computer-based e-DaMath on February 21-23, 2001 at Cebu City National Science High School, Cebu City.
- 2. The said activities aim to:
 - a. promote awareness of learning with localized technology in mathematics among the youths in particular and the public in general;
 - b. enhance pupil/student achievement level specifically on higher order thinking skills in mathematics through the use of indigenous games;
 - c. encourage emotional intelligence among participants in a learner-friendly academic competition; and
 - d. tap the active participation in education by the private and business sectors through the "Adopt-A-School Program (Sponsorship of Pupil/Student Contestants' travel expenses to and from the national competition venue)" as finance resource mobilization scheme.
- 3. The national DaMath competition categories and the tentative schedule of activities are contained in the enclosure.
- 4. The national winners will receive the DOST commemorative brass-in-fiberglass trophies, the Bato-Balani Foundation, Inc. commemorative medaltions, and the Belgosa Media Systems, Inc. assorted sci-math books and cash prizes, while their teacher-coaches will receive plaques of recognition. Likewise, all the national finalists and their teacher-coaches will receive the Bato Balani Foundation, Inc. commemorative medaltions.

- 5. The participants to this activity are the regional champions (1st place) from each region and their teacher-coaches. Thus, the official list of participants (4 contestants and 4 teacher-coaches, i.e. 8 persons per region) shall be sent by fax or e-mail to the Regional Director, DECSRO VII, Lahug, Cebu City (Attn.: The SED Chief) copy furnished the Director, Bureau of Secondary Education, DECS, 3/F Bonifacio Bldg., Meralco Ave., Pasig City, fax no. (02) 632-7746, e-mail url http://ilhuenda@decs.gov.ph (Attn.: Mr. Jesus L. Huenda, e-DaMath Project Team Leader) on or before January 26, 2001.
- 6. The travel and other incidental expenses including the nominal registration fee of One Thousand Two Hundred Pesos (P1,200.00) to cover eight (8) meals, five (5) snacks and 3-day lodging of the teacher-coaches shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations. Private school teacher-coaches may make arrangements with their respective school heads. Payment in check or money order shall be addressed to DECSRO-VII. However, the said registration fee and travel insurance of pupil/student contestants shall be borneby the Belgosa Media Systems, Inc. through Bato Balani Foundation, Inc., by invoking the legal provisions of the "Adopt-A-School Program (Sponsorship of Pupil/Student Contestants)". It is expected that the usual submission of the health certificate and parental consent/waiver required of each of the pupil/student contestants shall be enforced by the host region.
