Start of holding political conventions or meetings for the nomination or selection of official candidates for national and/or local positions of any political party or organization or political groups or coalition.

Deadline for filing petitions for registration of political parties

ELECTION PERIOD

Last day to file applications for registration, transfer of registration records, etc.

Posting of notices of hearing of applications for registration, transfer of registration records, etc.

Period for the filing of certificates of candidacy for elective positions in the ARMM

Period for the filing of certificates of candidacy for all elective positions outside of the ARMM

Last day to file opposition/challenge to applications for registration

Last meeting/s of the ERB to approve or disapprove applications for registration.

Last day to establish or create new precincts or alter territory of an election precinct


Last day to submit certificate of nomination of candidates of registered political parties

Last day for party, organization or coalition aiready registered with the Commission to file manifestation of desire to participate in the party-list system

Last day to file petitions to deny due course or cancel a certificate of candidacy

> Last day to file a petition to declare as nulsance a registered candidate

Filing of petitions for inclusion of qualified voters in the List with the proper Municipal or Metropolitan Trial Courts for those whose applications for registration have been disapproved by the Board or whose names have been stricken out from the list.

Posting of certified list of voters and precinct maps

Campaign period for Senators and parties, organizations or coalitions participating under the party-list system

Last day for jail officials to post in three (3) conspicuous places the list of prisoners or detention prisoners under their care

Notice of inspection and verification of completeness of the VRRs for each precinct compiled in the book of voters.

> inspection, verification and sealing of books of voters

Last day for heads of all reaction forces, strike forces or similar forces to submit to the Commission a complete list of all members thereof with such particulars as the Commission may require

Campaign period for Members of the House of Representatives and elective regional, provincial, city and municipal officials

Last day for submission of nominees for party-flat representatives

Last day to close and seal the book of voters

Last day to furnish every registered voter with an official sample ballot, voters information sheet (VIS) and list of all national, party-list candidates, provincial and city candidates to be voted in the election.

Last day of campaigning for all positions



- Bearing, carrying or transporting of firearms/deadly weapons, including wearing of uniforms, insignias, etc.
- Transfer or detail of officers and employees in the civil service, including public school teachers.
- Organizing or maintaining reaction/strike forces or similar forces.
- Use of security personnel or bodyguards by candidates, whether or not such bodyguards are regular members or officers of the PNP or AFP or other law enforcement agency.
- Suspension of any elective regional, provincial, city, municipal or barangay officials



- Opening of booths or stalls for the sale, etc., of merchandise, refreshments, within thirty
 (30) meters radius from polling place.
