**NATIONAL SEMINAR-WORKSHOP IN MUSIC, ART
AND PHYSICAL EDUCATION**

1. The Sport Psychological Training, Consultancy and Research Center will be conducting a National Seminar-Workshop in Music, Art and Physical Education focused on the theme "Multiple Intelligences thru Music, Art and Physical Education: Bridging the Gap in Curricular Development". This will be held on April 18-20, 2001 from 8:00 a.m. to 5:00 p.m. at the Environmental Education Center, Miriam College, Katipunan Road, Loyola Heights, Diliman, Quezon City.
2. The objectives of the seminar are as follows:
 - a) acquire adequate skills in the formulation and conception of appropriate learning activities based on the nature, needs and developmental characteristics of the regular as well as the highly intelligent students in Music, Art, or in Physical Education;
 - b) enhance knowledge and understanding of a wide variety of musical experiences, creative art activities, and movement education as tools in developing the full potential of students;
 - c) keep abreast of the applications of current scientific research studies on Music, Art, and Physical Education with regard to teaching; and
 - d) value the importance of self expression, and creativity through the mediums of music, art and movement education.
3. Participants to this seminar are public and private school supervisors, department heads, Music, Art and Physical Education teachers in the elementary and secondary levels.
4. A registration fee of One Thousand Seven Hundred Fifty Pesos (P1,750.00) shall be charged each participant to cover the operational expenses such as training materials, training manual, certificate of participation, honoraria for speakers, snacks, lunch and other expenses related to the conduct of the activity.
5. Participants from the public schools are allowed to attend on official time only. Those coming from the private schools shall make financial arrangements with their respective institutions.
