The first prize winners in both categories received a four year music scholarship in pre-selected schools (UP, UST, St. Scholastica's College and PWU), Php 10,000.00 cash, one (1) audio system and a trophy. The second prize winners received a six-month music scholarship (Ryan Cayabyab School of Music for the Solo Vocal Performance Category while the pre-selected school for the song writing category is the Yamaha School of Music), Php 5,000.00, one (1) audio system and a trophy. The third prize winner in the songwriting category received a three-month music scholarship (Yamaha School of Music) and a trophy.
- 4. The schools whose students won the first prize for each category received a Karaoke from Kenny Rogers Roasters. The winners need to apply for and pass the entrance exam of the pre-selected school of his/her choice. Music scholarships are non-transferable and not convertible to cash.
- 5. All DECS regional and division coordinators are commended for their support to MUSIKA, thus ensuring the success from the preliminary judging and the Grand Finals.

KENNY ROGERS ROASTERS MUSIC COMPETITION

I. GENERAL REQUIREMENTS

- A. The contest is open to all private and public high school students who are Filipino citizens currently enrolled in the schoolyear 1999-2000 in any DECS-recognized high school in Luzon.
- B. The contest is open only to amateurs and non-professionals.
- C. Entry forms are available at any Kenny Rogers Roasters' outlet.
- D. The entry form must be completed by the contestant and duly endorsed and signed by both the contestant and school's music teacher.
- E. The entry form must state the following complete information:
 - 1. Contestant's name
 - 2. Address
 - 3. Phone number
 - 4. Age
 - 5. Name and Address of School
 - б. Year in High School
 - 7. Name of Music Teacher
 - 8. Signature of Contestant
 - 9. Signature of Music Teacher
 - 10. Name of Parents or guardian
 - 11. Signature of Parents or guardian

II. CONTEST MECHANICS

- A. There are 2 categories for the Kenny Rogers Roasters' music competition:
 - Music composition category
 - Solo vocal interpretation (Any vocal piece with or without back-up, 4 back-up members at the most).
- B. Music Composition Category
 - All entries must be original compositions by the contestants, never been published, recorded and released for information, advertising and commercial purposes.
 - 2. The song should capture the theme "Celebrate the Filipino Youth-its vision, mission and hopes for the next millenlum— in song!".

- 3. If a songwrit has submitted an entry in collaboration with a composer, same composer will not be allowed submit his/her own separate entry.
- 4. Entries must be recorded on tape accompanied with the music sheet only.
- 5. Entries can be in English or Filipino.
- Entries must be at least 2 minutes (120 seconds) and no more than 3 minutes long (180 seconds). Any entry shorter or longer than required will automatically be disqualified.
- 7. Each entry must be wholly original. If an entry is found to contain four (4) or more consecutive bars of melodic content or lyrics exactly like that of another published or released song either locally or abroad, this entry will automatically be disqualified.
- 8. All recorded entries on tape must be accompanied with three (3) typewritten copies of the lyrics and must be sung by one (1) or two (2) up to three (3) singers only and accompanied by any of the following instruments namely: piano, organ or gultar. Others than those stated above will be disqualified.
- 9. Verbal introductions or explanations that are not part of the song should not be included in the tape.
- 10. By entering a song in this competition, the participants warrant that it has not been contracted for by any third party and that he/she shall not negotiate and/or contract for use of the song with any such third party until after the announcement of the winning entries.
- 11. The songwriter shall hold Kenny Rogers Roasters', its affiliates, officers, employees and members of the contest committee, free and harmless from any suit, demand, debt, obligation, expense or liability arising from any misinterpretation in connection with his entry submitted to the competition.
- 12. All official entries must be placed in sealed envelopes together with the duly accomplished entry forms. The contestant's name and address and phone number must be clearly written in front of the envelope.
- 13. Entries must be performed as submitted.

- 14. All sealed envelopes can be dropped at the drop boxes located at the nearest Kenny Rogers Roasters' outlet.
- 15. While the winning entries will be judged based on the totality of the song (lyrics, interpretation, etc.) prizes will be awarded only to the songwriter.
- 16. Deadline for submission is on September 30,1999.

C. Solo Vocal Performance

- 1. All entries must be recorded on cassette tapes with or without accompaniment.
- Entries need not be original compositions.
- 3. Valid Entries must be in the ff. music formats:
 - a. Pop
 - b. Ballad / Standard
 - c. Folk / Country
 - d. Classica!
 - e. Broadway
 - f. Folk / Ballad (Kundiman)
- 4. Entries must be in either English or Pilipino.
- Entries must be at least 3 minutes (180 seconds) but not more than 4 minutes (240 seconds) long. Any entry shorter or longer than required will automatically be disqualified.
- All official entries must be placed in sealed envelopes together with the duly accomplished entry forms. The contestant's name and address and phone number must be clearly written in front of the envelope.
- 7. The singer shall hold Kenny Rogers Roasters', its affiliates, officers, employees and members of the contest committee, free and harmless from any suit, demand, debt, obligation, expense or liability arising from any misinterpretation in connection with his/her entry submitted to the competition.
- All sealed envelopes can be dropped at the drop boxes located at the nearest Kenny Rogers Roasters' outlet.
- Deadline for submission is on September 30, 1999.

D. Elimination Process

- 1. Upon receipt of all sealed envelopes, a code number will be assigned to each entry for both categories.
- 2. All entries will be reviewed by a screening panel to determine the
 - a. Authenticity / Originality
 - b. Validity
 - c. Value / Worthiness
- 3. An elimination round for every category per designated area (i.e. Makati Area, Mandaluyong Area, QC Area, etc.) will be conducted in order to determine who will qualify for the area finals.
- 4. All contestants will be given an acknowledgement letter upon submission of their entry. Only the winning entries will be notified in writing for the area finals.
- 5. All performers and/or composers for the music competition category shall assign in whole the original compositions contained in music sheets or recorded on tape to Roasters Philippines Inc. upon the submission thereof to the outlets mentioned herein. All performers for both categories shall formally authorize Roasters Philippine Inc. to enjoy the exclusive rights as regards their performance and reproduction in whatever form (i.e. cassette tapes, CD, etc.) provided under the Intellectual Property Code.

Any and all rights found in the same Code derived by the performers and/or composers from the music competition and the performance shall likewise be assigned to and enjoyed by Roasters Philippines Inc. without any renumeration therefor.

- 6. All contestants accepted to the area finals will be requested to perform their entries at a designated public venue, which shall be duly announced in a major publication and in the posters located in all Kenny Rogers Roasters' outlets. The winning contestants to the area finals are required to shoulder all their expenses to the designated public venue (i.e. transportation, lodging, meals, etc.)
- 7. The area finals for the 2 categories will be conducted in the following areas:
 - a. Manila
 - b. Quezon City
 - c. Makati City
 - d. Mandaluyong City

e. South (Lipa and Bacoor)

- There will be one winner per category in every area on the area finals (e.g. for Manila there will be one area finals' winner for composition and one for vocal interpretation)
- All area finals winners will compete for the Grand Luzon finals at the Cultural Center of the Philippines on Jan. 28, 2000. The area finals winners are required to shoulder all their expenses to compete at the Cultural Center of the Phillipines (i.e. transportation, lodging, meals, etc.)

10. Prizes at stake:

- a. Area Finals First Prize 5,000.00; Second Prize 3,000.00;
 Third Prize 1,000.00. Gift items from Kenny Rogers Roasters' for composition and vocal interpretation winners.
- b. Grand Finals trophies and a four (4) year music scholarship for the top winners for both categories. The music scholarships are non-transferable and not convertible to cash. The schools for the music scholarship are the following: University of the Philippines, University of Sto. Tomas, St. Scholastica's College, Philippine Women's University, Ryan Cayabyab School of Music, Center for Pop Music, Yamaha School of Music and RJ School of Music.

E. Contest Restriction

- Contestants are allowed to submit a maximum of two (2) entries per category.
- 2. Contest is limited to Luzon-based high school students.
- Entries submitted beyond the deadline are definitely not eligible for the contest.
- All employees of Kenny Rogers Roasters' and their relatives within the second (2nd) degree of consanguinity and all employees of its advertising and promotional agencies are not allowed to join this

III. JUDGING

- A. Five (5) Judges will screen the entries for the solo performance and five (5) Judges will screen the entries for the music composition.
- B. For the area finals, three (3) or five (5) judges per area will decide who will compete for the Grand Finals. Judges will be members of the academe, music teachers or professional musicians.

- C. For the Grand Fire 's, a Board of Judges composed of Fig. (5) members will determine the Grand Champions for both categories.
- D. Judges' decision is final.
